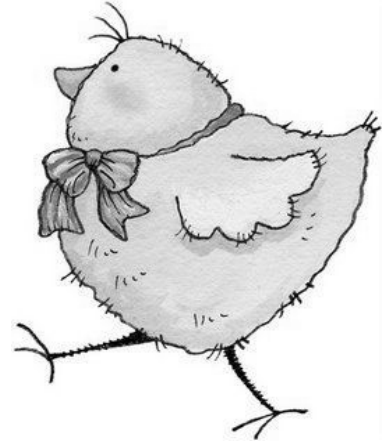

DON'T FORGET! All dogs, five (5) months of age and older, must be licensed in the Village each year. Fees for 2026 are: Males/Females \$10 or Neutered Males/Spayed Females \$5. Owner must show proof of rabies vaccination.
