Public Comments

William Johnson showed an ad from a national magazine for our Soo Line Depot/Museum put out by the Historical Society. He informed the Board of some of the different groups they are a part of that helps expand their presence. He also said that the Polk County Tourism Council has invited the public to the 300 Club for an event that's planned outcome is to show Polk County, and possibly our Towns and Villages where we should be marketing our tourism dollars to bring in people from outside areas.

Lee Huber, Operations Manager for Lakes Region EMS/St. Croix Valley EMS made himself available to answer any questions the Board may have to keep them in consideration for the upcoming ambulance service decision that will be made. After some questions and answers, it was decided to be added to the May Agenda.

Frederic Arts Banner Proposal – Ann Wolgamot

On behalf of the Frederic Arts Board, Ann presented a project that would create light pole banners to be hung during the summer in the Village. Contestants from different age groups would submit their designs with multiple winners having their artwork printed on the banners. They will inquire with the school about using the same hardware that hangs the Senior Banners to avoid that extra cost. The hope is to get approval for the project from the Board, and possibly a donation to help offset the cost. After getting an answer from the school and knowing the final costs, the Board will make a decision at next month's meeting.

Committee and Department Head Reports

a) Public Works – Bill Struck: Run water orders are still in place. After attending training in La Crosse, more was learned about the new lead and copper regulations and what we will need to do to be in compliance by the 2024 deadline. A few sewer mains froze up this winter, but were all caught before they affected any homes. The final draft for the Waste Water permit was approved by the DNR and we are on schedule to start the new irrigation system in July. Street sweeping and pothole filling has begun. One storm sewer froze up and is presently being worked on. A reminder to Village residents, that if they have a lot of stick/branch/yard waste, Public Works will deliver a truck at the start of the day for you to fill up, and it will be picked up at the end of the day, at no charge to you.

b) Park Board – Rebecca Harlander: Pete and Carol Mangelsen will be returning this year as Park Caretakers. Another camera has been purchased for the west park area. A door has been ordered to replace the one damaged by the park kitchen vandals. The vandalism clean-up to the boardwalk still needs to be resolved. We accepted a donation from South Fork Sporting Club to help pay for a new fishing pier needed at the park after vandals ruined one. 2 memorial benches for the Village are in the works. We will be applying for an 80/20 grant for the trail around the lake. Polk County forester, Paul Heimstead will be accessing our wooded area on the east side of Coon Lake to see about finishing a harvest project that was started in 2015, but was halted due to the ground being too wet.

- c) Library Kris Surbaugh: The monthly activity sheet was handed out. The computers are in the process of being updated, which will include software giving the ability to print directly from a customer's personal device. The bicycles and pickle ball court supplies have been brought out for the season. A birding class will be held on April 23rd. A gardening class is planned for May. A collaboration with the 53 other libraries in our system for a "passport" contest that encourages you to visit as many of them as possible. Northwest Passage kids will resume coming in after a long Covid hiatus. Kris announced her retirement and her last day of work is May 27th.
- d) Law Enforcement Tamara Larson: The calls for service were very high in March. Randall was brought back on to use as a transport officer to help alleviate the huge time consumption that is added with those calls. A student asked if T Larson could drive them in the squad to Prom. A Northwest Passage transport person did \$600 worth of damage to the inside of the squad car. The county that this juvenile is from has been billed for the damage, but that doesn't guarantee we will be paid. T Larson met with Polk County's CJCC (Criminal Justice Collaborating Council) about a new program for young first-time offenders to potentially avoid getting a lifelong felony charge that will follow them for the rest of their life and the Intoxicated Driver Intervention Program that can help get needed treatment and/or help instead of just a punishment.
- e) Clerk/Treasurer Janice Schott: The election had a lower than normal turn-out. We are still getting quotes for a new copier. Our property tax Open Book and Board of Review are both coming up.
