#### **Public Comments**

John Brand, Reba Boucher and Jackie Thorwick spoke on an ongoing situation at the Sunrise Apartments where Reba lives. They feel Reba is being harassed and blamed for things that she did not do, and would like a hearing to tell their side of things before the eviction of Reba takes place.

Roxanne Howe asked the Board, when considering the UTV/Equestrian Study from Polk County Government, to see also the positive side of allowing UTVs and equestrians to share the Polk County stretch of the Gandy Dancer Trail, including at least 15 Village businesses that could see increased revenue.

#### **Committee and Department Head Reports**

- a) Public Works Bill Struck: None
- b) Park Board Rebecca Harlander: The Park Board had the first meeting of the year and are starting to plan for summer. An anonymous donor has offered to put a swing set at the new playground area. The library is planning a couple events at Coon Lake Park this summer. The meeting with the consultant for the UTV/Equestrian feasibility was postponed, but questions were sent out that can be answered and the meeting will hopefully be rescheduled.
- c) Library Amanda Blackmon: The jigsaw puzzle competition and 7-year-old author meet and greet were both successful. Chess Club and the Friday play group is still going on. The Summer Reading Program is being revamped.
- d) Law Enforcement Tamara Larson: February had 224 Calls for Service. A used squad from Osceola is in the process of being purchased. Officer Randall Selle has given his notice and will be going back to his previous job in Burnett County.
- e) Clerk/Treasurer Janice Schott: We have applied for and should receive a \$7000 Police Department grant that will reimburse them for expenditures, including fuel and uniforms, freeing up that budgeted money to be possibly put towards the new squad car from Osceola. The property tax Open Book has been scheduled for April 12<sup>th</sup> and is via phone with the accessor. The Board of Review will be May 8<sup>th</sup> from 6:00 pm and end at 8:00 pm going through our regular board meeting. The Spring Election is April 4<sup>th</sup>.

f) Public Works – Duane Wisse: The Committee discussed the parking problems on Birch Street and recommends the Village Board makes it no parking on both sides year-round. The Committee also discussed the vacant lot at Polk/Elm and recommends the Village Board considers selling it. Representatives from the DNR zoomed in with a presentation on a US EPA Lead Service Line Accelerator Program that will help identify any lead lines in the Village and seek possible funding options for the replacement of those lines. The Committee recommends the Village Board accept this offer.
