### 9. Committee and Department Head Reports

- a) Public Works Bill Struck: Public Works is being more diligent with their hygiene methods. Practicing social distancing with each other and the public. They have been sweeping streets and filling potholes. Visu-sewer is done with their work and Bill has been working with MSA on the grant. A Lahti thanked Bill for working with Starwire to get the boulevards restored after their work.
- b) Park Board Rebecca Harlander: Parks are currently closed due to Covid19, except for walking and fishing. Community Give Back day has been cancelled this year. Rebecca will work with Mr. Krueger to try to get the roof done on the South shelter. The Park Board will continue to work on gardens while practicing social distancing.

- c) Library Kris Surbaugh: The library has been closed due to Covid19. They have just started offering curbside service. Staff has been working on policies and doing story time on Facebook Live. They are anxious to reopen when it is safe to do so.
- d) Law Enforcement Tamara Larson: They have implemented Covid19 protocol. The department got a K9 Drug Grant, this grant will cover training for the department K9s. Taser is in his fifth week of school and is doing good. The new squad truck is at Larsen's getting a bedliner. Squad car received some damage in a high-speed chase but Polk County Sheriff's department will cover the cost of repair. Welcome to new and returning board members and thank you to departing members.
- e) Treasurer Jennifer Phernetton: Auditor has completed the 2019 audit and the final report should be received in the next week or two. Explained a document that was included in the packet regarding a report by a financial consultant, an expense that was approved previously by the Finance Committee. Hazard pay was given to the election workers that worked at the April Election. There has been no change to funding announced due to Covid19. Welcome to new and returning board members and thank you to departing members.
- f) Ambulance Report Postponed and rescheduled for May 27, 2020.
- g) Personnel/Finance Becky Amundson: Met on 4.2.20 discussed the six-month review of police officer B Schlueter and extended probation period.
