Friends of the Gandy Dancer Bike Expo

Mark Buley gave information about the Bike Expo to be held on August 16, 2025. They would like to use the greenspace on the south side of the pickleball court. This is also the 30th Anniversary of the Gandy Dancer and the same day as the Historical Society Pie Social. William Johnson added that this is the first year of the Bike Expo but there are plans to make it an annual event.

Wisconsin Avenue – Pay App No. 1

Drew Lindh, MSA, reviewed the pay app in the amount of \$915,399.76. The contractor needs to complete some paperwork before the payment will be sent.

Proposed Cost for United Way Curb and Gutter, Public Works Recommendation

Drew Lindh, MSA, reviewed the quotes received to add curb and gutter to United Way. This expense will come from the street maintenance budget line item.

10-Year Transportation CIP Public Works Recommendation

Drew Lindh, MSA, explained that the Capital Improvement Plan (CIP) needs to include Polk and Lake Avenues in order to apply for certain funding. There has been more wear and tear on Polk and Lake due to construction on Wisconsin Avenue.

Motion to approve update to CIP to include Lake and Polk Avenues by B Harlander/D Wisse. Vote: Carried

Water Rate Increase Public Works Recommendation

Drew Lindh, MSA, discussed the need to look into raising water rates to meet revenue shortfalls due to upgrades and increased maintenance costs. The Village should begin with contacting the auditor and requesting a quote to assist the village with a conventional rate case with the Public Service Commission.

Motion to approve J Schott reaching out to auditor to obtain a quote to assist Village with a water rate increase by R Lillehaug/P Swenson. Vote: Carried

Frederic Grocery Co-Op Fiscal Sponsorship Request

A Blackmon explained that the Frederic Grocery Cooperative steering committee has the opportunity to apply for a grant to cover the expense of becoming a cooperative. In order to be qualified to apply for the grant they need an approved entity already allowed to received grants. The Village would accept and administer funds, disburse funds for approved project purposes, maintain financial records and reporting and ensure that all grant funds are used for project-related purposes only. The sponsorship will be terminated when the grant money has been spent. A Blackmon assured the Board that there is no liability for the Village.

Motion to approve the fiscal sponsorship agreement as presented by B Harlander/D Wisse. Roll Call Vote: D Wisse Yes, B Harlander Yes, R Lillehaug Yes, J Peterson Yes, P Swenson No, B Morris abstained and A Blackmon abstained. Carried

R Lillehaug asked about the dugout plans mentioned in the Parks report. P Swenson stated that the Park Board is getting input from local coaches on the best layout.
